

## Convocazione con Papa Francesco

Roma, Stadio Olimpico 1 e 2 giugno 2014

---

### Behavioral rules to be observed during the event

---

The access and permanence , for any reason , within the sports are governed by the " Rules of Use " . Please note that the participant, in particular , is obliged to respect and follow the behavioral norms , prohibitions and warnings:

We recall , in particular, the following provisions:

- a. The Access Pass to the Stadium is strictly personal and cannot be transferred to third persons.
- b. To access to the plant is required to hold a valid identity document , to be shown upon request of the stewards ( the responsible person in charge of surveillance and security) .
- c. It is mandatory to show the pass already in early access gates . Security personnel carefully checks to prevent unauthorized persons from accessing e.g street vendors.
- d. It is not allowed to access to different sectors than the one assigned and specified color (BLUE , RED , ORANGE) , either from the inside or from the outside.
- e. The Access Pass must be kept until the exit from the stadium and for both days.
- f. The access to the system is allowed only once. It is therefore not expected to go out and come back with the Pass after passing through the entrance turnstiles on the same day . Exceptions to this provision may only be authorized by the Organizational Directorate for details and mandatory requirements and will then be regulated to the appropriate passages .
- g. The participant has the right / duty to occupy the place and , therefore , with the withdrawal of the Access Pass is not allowed to occupy temporarily released seats used by other people.

h . The participant may be subjected, by the assigned security staff and policemen and by means of a metal detector , to checks in order to prevent the introduction of illicit prohibited and / or dangerous materials , and is required to follow the instructions given by stewards ( the staff responsible for security) ;

## **Inside the sports stadium it is FORBIDDEN to**

---

- a. access other sector other than the one assigned , both inside and outside the plant.
- b . Stay in the vicinity of passages, exits , entrances, along the access roads , and any other escape without a right reason,
- c . For disposal of Public Safety it is forbidden to bring into the Stadium umbrellas, strollers, baby pushchairs , folding chairs , stools , and any other object that can be treated , in the opinion of the staff , as improper weapon . An exception is any crutches and walking sticks for the elderly and disabled .
- d. Occupy the access roads , the passageways and stairs with strollers , wheelchairs, stools, chairs , backpacks and anything else that could prevent an easy escape route for people.
- e . Climb banisters , railings , partitions and other structures not designed specifically for the stationing of the public.
- f . Damage or violate in any way facilities , infrastructure and services of the plant.
- g . Introduce or hold poisons, toxic substances , flammable or materials or drugs.
- h . Introduce or sell alcoholic beverages with a graduation of no more than 4 ° , unless derogation licenses for particular areas , issued by the competent authority , with the approval of the commissioner.
- i . Smoke in all areas of the stadium (except for the " external " areas of the sectors) .
- j. Exhibit material that obstructs the visibility to other participants or emergency signs or otherwise be an obstacle to the escape routes from the pitch.
- k. Perform any kind of business that has not been authorized in advance .
- l. Introduce and sell inside the stadium , drinks contained in cans , glass bottles or plastic. Even glass bottles .
- m. Introduce animals of any kind , except under expressed authorization .
- n. Introduce and expose banners, signs , horizontal banners , streamers , documents, drawings, and written or printed materials other than those specifically authorized by the Security Operations Group (GOS ) at the request of the Organization; however the

same cannot be exposed in areas other than those indicated by the organization and must be removed at the end of the event.

- o. Organize unauthorized choreography or different from those authorized by the Operational Group for Security (GOS ) at the request of the organizers.
- p. Enter and remain in the plant while intoxicated or under the influence of drugs or psychotropic substances .
- q. Introduce or hold stones , knives, objects acts to offend or capable of being launched, sound instruments , systems for the transmission of light beams ( laser pointers ) and other items that may cause trouble or danger all'incolumità of all those present in the ' plant .
- r. Introducing belts with metal buckles and other accessories of significant size or aids that may cause danger to the safety of the event.
- s. Introducing umbrella, except for those of small size , however not having sharp points and shape and / or materials that may cause danger to the safety of the event and of the spectators ;

## WARNINGS

---

**The statements herein are intended to facilitate public order and security within the sport plant. Therefore :**

Please note that the following behaviors, as well as being subject to administrative sanction for violation of this regulation , it can also integrate offenses :

- a. Misrepresentation, possession of proper and improper arms, the display of emblems or symbols associations that spread discrimination or violence on racial, ethnic, national or religious incitement to violence during sports competitions , the possession , the launch and use of hazardous materials and fireworks , the jumping of the separators, the invasion of the pitch;
- b. It should be noted that the plant is controlled by a system of audio-video recording, both inside and outside, whose data are processed by the plant in accordance with the provisions of Legislative Decree 30 June 2003, n. 196 and the Ministerial Decree 06/06/20
- c. It should be noted that the stadium there will be no distribution of Pass. It is useful, therefore, to discourage those who participate and that in departure they are not equipped with the Pass.
- d. It is advisable to pay attention to the up / down of the stairways .

- e. It is advisable to avoid going up and down continuously from the steps, except in cases of necessity and urgency. This warning is even more restrictive for older people and parents with small children in their arms.
- f. It is advisable not to introduce umbrellas, except small ones , though not with sharp points and shape and /or material that may cause danger to the safety of the event's participants.
- g. To make easy the entrance and exit from the stadium, it is essential to have the mobile number of the team leader.

h. It is imperative to follow the procedures for access and exit provided by the organization and contained in the "Organizational Notes" communicated to the participants.  
These provisions are mandatory in order to ensure public order and the safety of participants.

i. We suggest that you DO NOT clog the infirmaries unless absolutely necessary.

j. We recommend that in your bag BRING ALL DRUGS usually taken for their own personal therapy and related medical prescriptions. The infirmaries will be provided only generic drugs and first aid.

k. It is mandatory for the participant affected by pathologies, to carry a sheet to show, in which are shown:

- **The most important diseases certified**
- **List of medications that can NOT be taken**
- **The CHRONIC THERAPY IN ACT**

l. Persons with pacemakers should ALWAYS bring a medical document certifying the possession .  
In case of any controls with metal detector on the person , **she/he must communicate to have a pacemaker before the operation.**

m. The visit of the Holy Father Francis will be governed by a special security protocol agreed by the competent authorities and vigilance and previously communicated .

n. It is advisable to avoid to purchase any materials ( objects, food and / or drink) from street vendors near the stadium , both for reasons of personal safety , and not to encourage such activities in conjunction with the Convocation . Authorized outlets are present in the plant after access to the turnstiles.

o. Please note that the staff at the turnstiles is treated as Public Safety is authorized to withhold any object that is not allowed (see previous points q, r , s) .
